Name of Project:	BRIPC IP Capability Online Training Program for IP Practitioners
Head Office:	China National Intellectual Property Administration (CNIPA)
1. Description:	This project aims at: Enabling the trainees from the BRI partner countries to expand their IP knowledge on IP systems, laws, policies, practices, etc., including those of China; Facilitating the BRI partner countries to file IP-related applications in China; Better protecting the legitimate IP-related rights and interests of the right-holders of the BRI partner countries in China; Sharing the experiences and best practice of IP development in China.
2. Project Approach:	 [Program Description] Two types of training programs will be offered under this project. - Type A training program will select a number of basic and general courses for all kinds of IP practitioners such as IP officials, IP lawyers, IP practitioners at enterprises, R&D technicians, innovators. The program study will be self-paced and available to sign up at any time of the year. - Type B training program will provide a selection of advanced and themed courses which are tailored to the need of specific group of IP practitioners such as IP officials, or IP lawyers, or IP practitioners at enterprises. The program will be available within some certain fixed period throughout the year. Two types of training will be implemented in English language via the distance learning platform of CIPTC, a multi-function platform where trainees can register the specific training program and take the training courses. [Implementation] ◆ Short-term goal - The Type A training program for 2024 has already launched with 7 courses. Trainees who complete the course study within a certain prescribed period after the course registration will obtain a certificate of completion issued by the CIPTC. ◆ Mid-term goal - In parallel with the Type A training program, CIPTC will also organize
	the Type B training program according to the training plan of CNIPA or the needs of the IP Offices of the BRI partner countries. Trainees will obtain a certificate of completion issued by the CIPTC. Long-term goal - Developing more high-quality courses, organizing more customized training and offering more specific courses on comparative studies.



[Eligibility for Participation] The project is open to all BRI partner countries. [Expected Contribution from Participating Offices] The participating IP Offices are expected to provide the contact person information and keep close communication with CIPTC. The participating IP Offices are expected to publicize the training programs in their own country and are encouraged to organize their trainees to take part in the training program. The participating IP Offices are also welcomed to making proposals on their specific training needs.

Featuring the introduction to the patent, trademark, copyright systems in China, this training program will enable the participating trainees to gain overall IP-related knowledge about China in terms of its IP system, and IP-related laws, policies, practices. The program is expected to serve as a source of inspiration for the IP practitioners from the BRI partner countries to leverage IP as a powerful tool for growth and sustainable development through the fostering and protection of creativity and innovation.
